Apply adhesive to one substrate, minimizing adhesive build up. <ol style="list-style-type: none"> a. For stronger bond apply adhesive to both substrates 3. Spray pattern should be consistent with ~1-2 inch overlap. 4. The adhesive is ready when no longer wet and it is tacky to the touch. 5. Attach materials using heavy uniform pressure. 6. Adhesive should remain tacky and ready for bonding materials for about 60 minutes. Temperature, humidity, and dust may change open time.
